*Regular grower* dues are \$120.00 annually.

*New growers*, just starting out, may join the association for \$50 annually. New growers may pay the reduced dues amount for a maximum of 3 years or until they begin selling trees, whichever is first.

*Growers in states other than Alabama, Louisiana and Mississippi* may join for \$60 annually. These growers will be listed on the SCTA website under "Other States" and will be non-voting members of the association.
